# NHS R&D Service Delivery and Organisation programme

The NHS R&D service delivery and organisation programme has commissioned a group of University of York researchers to review the evidence between staffing and outcomes in primary and secondary care. Specifically, this scoping report will use a systematic approach to take a broad sweep of the relevant literature in order to:

- Identify, categorise and summarise research examining the effect on patient outcomes of staff/patient ratios and the degree of training or specialisation of the staff.
- Assess the reliability of the data sources and the quality of the methods used to see the extent to which the results are valid and to make recommendations about ways in which methods could be developed to produce more robust evidence in the future.
- Map out the significant gaps in knowledge where more research might add value either through addressing new questions or replicating international research in an NHS setting.
- Consider, with the input of policy makers, professional organisations and those responsible for education and development, the possible implications for health care policy.

There are policy questions associated with these four issues, e.g.:

- To what extent are workforce staffing decisions historically determined?
- What examples exist of changes in staffing or staff management to improve outcomes and/or throughput?
- What evidence is currently being used to make staffing and staff contract decisions?
- Are there rational reasons for the considerable variation in staffing levels, as shown, for instance, in the Dr Foster Hospital Guide? (http://www.drfoster.co.uk/hospital\_guide/main/choosehospital.asp)
- What specific questions regarding the relationship between staffing, staff contracts and outcomes are priorities for research commissioning?

Our aim is to ensure that policy makers like you are aware of our work and have an opportunity to contribute to it. Prior to our meeting, we would be grateful if you could gather together any unpublished materials that would inform our study.
